

**Virtual School Information**

✓ **Students should speak with their guidance counselor BEFORE registering for a virtual school course.**

- Students are permitted to take no more than two virtual school courses during a semester.
- Coursework can be retaken for remediation if a grade of D or F was earned.
- Prerequisites may exist for a course. Make certain you have met these requirements. Make certain you are registering for the correct semester.
- Grades earned through virtual school will be reflected on your Crooms AoIT transcript. If you change your mind about taking a course - drop it - or an F may end up on your transcript. Remember: *what goes on the transcript stays on the transcript!*
- Students are responsible for notifying guidance when credit has been awarded.
- Students are responsible for notifying guidance when credit does not appear on the academic transcript.
- You are responsible for your own computer, software, and Internet Service Provider when taking virtual courses.
- Your virtual school teacher will help you set a pace to complete the course in approximately 18 weeks for a semester or 36 weeks for a year-long course. Students may work more rapidly by submitting extra assignments. Your school district may have additional deadlines to consider when taking an online course. *Make certain you are submitting assignments regularly or you may be dropped from the class.*

➤ **FLVS** – register for courses on FLVS if it will be done *after* school hours.

◆ **SCVS** – register for courses on SCVS if it will be done *during* school hours.
